Research topic: Quaternary changes in vegetation and evolution of the cultural landscape of Europe in the context of climate change and human settlement development; the team of dr hab. Agnieszka Wacnik

The candidate must have proven the following competences/qualifications:

1. Doctoral degree in the field of biological science (or related discipline).
2. Knowledge in: biology with particular emphasis on archaeobotany, palaeoenvironmental studies and plant ecology.
3. Required professional experience in: xylological and anthracological analysis of fossil material; basic knowledge of palynological analysis; laboratory preparation of palaeobotanical samples; publication of scientific papers and writing of grant or patent applications; implementation of research projects funded as a result of competitions.
4. Publishing track record in the form of original papers published in international journals (following the Ministry of Education and Science list), including a minimum of 4 articles published in JCR-listed journals (also as lead author), confirming knowledge of the research methods required in the description of professional experience; authorship of popularising papers is welcome.
5. High research independence; readiness to work in teams; organisational abilities; readiness to work in the field.
6. Operating graphic programmes, including those specialised in palaeobotanical analyses.
7. Very good knowledge of Polish and at least good knowledge of English.

RESPONSIBILITIES:

- the scientist will develop research on vegetation reconstruction and history of human use of wood raw material by conducting research within the framework of Team IV.2 implementing the research topic: *Quaternary changes in vegetation and evolution of the cultural landscape of Europe in the context of climate change and human settlement development*; the basis for the analyses will be wood and bark, including preserved in the form of charcoal, which come from Quaternary natural deposits and archaeological sites from Poland and Europe;
- the researcher will prepare scientific and popularisation publications, grant applications for national and international competitions, conference presentations and activity reports.
